Caretaker Mode

Following the vote on 8 February 2023 by the members of Freemasons Victoria in favour of Constitutional change, the current Masonic Council has entered caretaker mode.

Caretaker mode will continue until 1 July 2023 when the members of the newly constituted Masonic Council have been elected.

The focus of the Council's work while in caretaker mode is to maintain the Masonic Operations to ensure that there is a smooth and transparent handover to the members of the new Masonic Council.

Current Focus

Reviewing regular reporting of the progress of various programs from the Membership and Education VATS. The success of the mentor program and the involvement and interest of many members in becoming involved as mentors is particularly pleasing.

The ongoing work of the Grand Inspector Workings re-establish the Exemplifications Team is supported by the Council as a means to reinvigorate ritual and ceremonial practices.

A detailed report on the membership movements across all districts was received that highlighted a number of reasons for members leaving the organization. This provides evidence for the development of appropriate strategies retain and grow are membership.

A final report with a series of recommendations has been received from Dr Samantha Fabry and will be considered by the Council with the aim to develop a strategy for the long term preservation and display of the extensive collection of historical items along with ensuring long term preservation and access to archival material for research purposes.

Meetings – December 2022 to March 2023

The Commercial Council members met on 19 December 2022, 16 January 2023 and 20 February 2023. The next meeting is scheduled for 20 March 2023.

A combined meeting with the Masonic Council and Board of Freemasons Victoria Holdings Ltd was also held on 16 January after the Commercial Council meeting.

Caretaker Mode

Following the vote on 8 February 2023 by the members of Freemasons Victoria in favour of Constitutional change, the current Commercial Council has entered caretaker mode.

Caretaker mode will continue until 1 July 2023 when the members of the newly constituted Commercial Council have been elected and appointed.

The focus of the Council's work while in caretaker mode is to continue managing work programs and projects already approved and to ensure that there is a smooth and transparent handover to the members of the new Commercial Council.

Current Focus

Property projects

The Council is reviewing a priority list of works to be undertaken and other property initiatives. This is being done in consultation with the property and business development staff at Freemasons Victoria and the Property Committee. Priority works are determined by health and safety considerations. The Council is overseeing existing approved works and preparing a list of future works to be recommended to the new Council post 1 July 2023.

Strategic Planning

The Council will be holding strategic planning workshops in April and May, in conjunction with the Masonic Council, to review the organisation's strategic plan and develop a strategic financial plan for investments and property for recommendation to the new Commercial Council post 1 July.

Other projects

Several other projects are being overseen by the Commercial Council. These include:

- An independent review of cyber-security measures at Freemasons Victoria.
- Updating the organisation's risk management framework and enterprise risk register to reflect its current risk profile and tolerances.
- Reviewing insurance coverage to ensure it is adequate and appropriate to the organisation's requirements.
- Overseeing the preparation of the 2023-24 budget.
- Reviewing the format and structure of financial reporting to the Commercial Council and the membership of Freemasons Victoria, including dashboard reporting.
- Monitoring the 2022-23 budget forecasts and preparing for the financial audit of the 2022-23 accounts. Deloitte was re-appointed as the auditor for this financial year.

Report to the Communication

March 2023

Royal Freemasons have enjoyed a productive start to the year with the sale of selected assets progressing steadily and important work being undertaken to support the exciting future direction of the organisation.

Sale of selected Royal Freemasons homes and communities

We are pleased to report that Aveo is the confirmed buyer of our Retirement Living communities Streeton Park and Redmond Park.

Aveo will officially commence ownership and management of these sites in April, date to be confirmed. Until that time, operations will continue as usual.

We are still in negotiations with a potential buyer for Berwick Brae Village and Canadian Pines Village and hope to have the contracts signed by the end of March.

With regards to Residential Aged Care, we are in negotiations with a potential buyer for Gregory Lodge, Bacchus Marsh and Ballarat and expect to sign contracts for the sale of these homes by the end of March.

We are currently undertaking a holistic review of Coppin Centre to maximise its ongoing effectiveness and identify opportunities to improve our services and offerings. The lessons we garner and actions we implement from this review will be applied to our other Residential Aged Care sites to ensure a consistent approach to the management and renewal of our homes, regardless of their whether they remain part of the Royal Freemasons portfolio in the future. Once completed, we will develop a master plan for Coppin Centre, exploring services and opportunities that are consistent with our heritage and values, and focussed on the needs of future generations as they age.

Following our decision to retain our Home Care services, we have begun a strategic planning process to identify future growth opportunities in this area, including partnerships with other wellness services, so we can expand our Home Care services to the broader community. For the long-term future, we are investigating how we can leverage innovations in technology to enhance our services in the home.

As our business evolves and changes, the care of our residents and consumers remains at the heart of everything we do and our number-one priority.

Changes to mask requirements in our Residential Aged Care homes

To everyone’s relief, we recently relaxed the mask requirements in our Residential Aged Care homes, in line with government guidelines.

The wearing of masks is now voluntary for staff and visitors, but we do ask that anyone experiencing flu-like symptoms must stay at home until symptoms clear. Staff and visitors are still required to complete a rapid antigen tests (RATs) and return a negative result before entering our homes.

With COVID-19 still in the community, we will continue to take a cautious approach and maintain strict infection control procedures to minimise the risk of infection.

Summer fun at our homes

It has been wonderful to see residents in our aged care communities across Victoria kick off the year with celebrations and lots of outdoor activities.

Residents at our Moe home have been making the most of the glorious summer weather by launching a morning walking group. When weather permits, they walk, scoot and wheel through the neighbouring park.

Recent events and news

It was wonderful to see **Australian Prostate Centre (APC)** featured on A Current Affair. This one stop shop for prostate cancer diagnosis and treatment in North Melbourne is a game changer for patients with prostate cancer and urology conditions, and FFV is tremendously proud of our significant contribution to the centre.

In December, Chairman Rodney Lavin JP attended the official opening of the **Maryborough Aeromedical Transfer Station (MATS)**. It's an indoor space for paramedics to treat patients while waiting to transfer them to air ambulances, and the Maryborough Community have spent four years campaigning and fundraising for it. FFV contributed \$25,000 to the project.

Rodney also attended the **Abbey Solo Foundation's T20 cricket game** in Sunshine West along with Western District Coordinator Emmanuel Marabeliotakis. The event raised \$8,500 to help families facing childhood cancer. They received a \$5,000 grant in our latest round of FFV Community Grants.

Finally, three tables of Freemasons and partners joined together to celebrate the work of one of our impact partners at the **Monash Childrens Hospital Gala**. An evening of entertainment and fundraising ensued, and the event raised more than \$1M for this important cause.

March 2023

Financial Performance

We can report that for the 6 months to December 2022, the consolidated result for Freemasons Victoria was a net surplus of \$1.4m compared with a budgeted surplus of \$672K for the same period. This favourable variation to budget was primarily due to lower administration costs in the General Fund, along with adjustments for the timing of Building Fund expenditure which will be occurring later in the financial year.

What are the prospects for the full 2022/23 year?

Activity is ramping up for the remainder of the financial year, especially in the area of building maintenance. The budget for 2022-23 is being reforecast to reflect the timing of this expenditure, along with updating forecasted investment income and expected revenue from property.

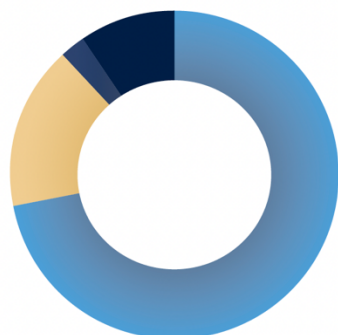
Preparation is also underway for developing the 2023-24 budget, where property and building maintenance expenditure will again be a key focus.

Financial Position

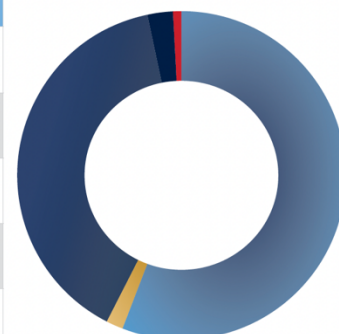
Our organisation continues to be in a sound financial position with no external debt. At the end of December 2022, we were holding approximately \$4.4m in cash and our managed investment portfolio had a market value of \$49.1m.

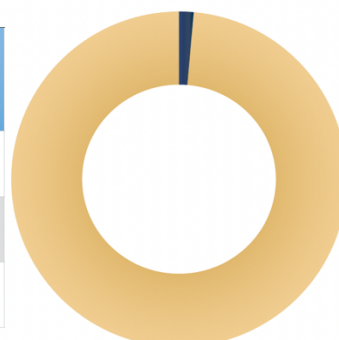
